## **Specification Definitions**

GVWR (Gross Vehicle Weight Rating) - is the maximum permissible weight of the unit when fully loaded. It includes all weights, inclusive of all fluids, cargo, optional equipment and accessories. For safety and product performance do NOT exceed the GVWR.

GAWR (Gross Axle Weight Rating) - is the maximum permissible weight, including cargo, fluids, optional by a combination of all axles.

UVW (Unloaded Vehicle Weight)\* - is the typical weight of the unit as manufactured at the factory. It includes LP Gas. The UVW does not include cargo, fresh potable

\*Estimated average based on standard build optional equipment.

CCC (Cargo Carrying Capacity)\*\* - is the amount of weight available for fresh potable water, cargo, additional optional equipment and accessories. CCC is equal to GVWR minus UVW. Available CCC should accommodate fresh potable water (8.3 lbs per gallon). Before filling
